**ORDER**

WHEREAS, the Eastern Regional Committee, NCTE had granted recognition to **Vinoba Bhave University, Vill.- Hazaribag, PO-Sindoor, Dist-Hazaribag, Jharkhand-825301 (Code No.APE01043)** for conducting **M.Ed.** Course of one year duration with an annual intake 25 students from the academic session 2009-2010 vide order No.ERC/7-100.6(I).1/2009/1364 dated 31.08.2009 followed by Revised Recognition Order No. F.ERC/NCTE/APE01043/M.Ed./ (Revised Order)/2015/32751 dt.31.05.2015 for M.Ed. course of two years duration with an intake of 50 students (one basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 284<sup>th</sup> meeting held on 17<sup>th</sup> – 18<sup>th</sup> September, 2020 considered the case of the institution and accordingly, recognition granted to M.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order F.No.ERC-284.15/APE01043/M.Ed./2020/63122 dated 05.10.2020 from the academic session 2021-2022.

3. **AND WHEREAS**, the institution preferred an appeal at NCTE Hqrs. against the ERC's order of withdrawal dated 05.10.2020. The Appellate Authority vide its Order No. 89-269/E-171037/2020 Appeal/14<sup>th</sup>Mtg.-2021/29<sup>th</sup>May, 2021/99884 dated 04.06.2021 remanded back the case to ERC with the observation that the appellant had submitted the fire safety certificate and list of required faculty before the Appeal Committee. Further, the Appeal Committee decided that the case of appellant be revisited by ERC after the appellant submits to them the latest Fire Safety Certificate and the list of required faculty within 15 days of the issued of appeal orders.

4. **AND WHEREAS**, the ERC in its 295<sup>th</sup> meeting held on 21<sup>st</sup> August, 2021 considered the original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, copy of appeal order dated 04.06.2021 and decided as under:-

**Restoration of recognition order of M.Ed. course with an annual intake of 50 (one unit) be issued.**
