- 2. The candidates shall be required to pay the Application fees of Rs. 750/- only through offline mode in Bank of India by the mode of Challan. No other mode of payment is acceptable.
- 3. On submission of the offline application form by the applicant, an acknowledgement receipt shall be given by the office bearer against all the formalities.
- 4. The submission of offline applications shall be automatically closed after a stipulated date and time.
- 5. Candidates are advised to visit the University website from time to time www.vbu.ac.in for any regular information and updates.

General Information about selection and admission procedure:

- 1. The admission of the selected candidates shall be done offline.
- 2. The requisite admission fees shall have to paid online within the stipulated period through bank.
- 3. Statutory Reservation policy shall be followed in preparation of the List of Provisionally selected candidates.
- 4. The University shall guide the provisionally selected candidates with detailed instructions in due course of time.
- 5. The admission done offline shall be purely provisional and subject to verification of original documents by the concerned offices at any course of time.
- 6. Admission cannot be claimed by any applicant as a matter of right. On being selected for admission the applicant shall have to appear before the admission committee at the University Law College with all original certificates /marksheets and other requirements on scheduled date and time. If any applicant fails to deposit the prescribed fee with in the stipulated period, his/her candidature shall be deemed to be cancelled without any further information.
- 7. Medium of Instructions shall be in English.
- 8. Candidates opting for the reservation policy during the admission process must have their cast certificates issued by the competent authorities to avail their seats.
- 9. For EWS categories candidates, certificates issued by the competent authority must be produced (if applicable).

- 10. For physically-challenged candidates, certificates issued by the competent authorities must be produced (if applicable).
- 11. Applicant shall have to mention their accurate email id and phone number in their application process for further correspondence.
