(If due to any exigency, the due date for opening of the bids is cancelled, the bids will be opened on the next working day at the same time or on any other day/time, as intimated by the University).

- 3. Place of opening of the bids:- The physical verification of tender document will be done at the Conference Hall of V.C.'s Secretariat, Vinoba Bhave University, Hazaribag. The bidders may depute their representatives, duly authorized in writing, to attend the opening of bids on the due date and time. This event will not be postponed due to non-presence of any representative.
- 4. Opening of Two Bid System:
 - i. The Technical Bids shall be opened as per date mentioned in this tender document.
 - ii. The Financial Bids shall be opened for only those bidders whose technical bids shall meet all the stipulated technical requirements and qualify in the evaluation of technical bid. The date of opening of financial bid will be intimated to the bidders after technical part formalities are completed.
- 5. <u>Rejection of Bids:</u>- Conditional bids will not be accepted. Canvassing by the bidder in any form shall lead to rejection of bids with forfeiture of E.M.D.
- 6. <u>Validity of Bids:</u> The bids should remain valid till **180 Days** from the date of opening of tenders from the last date of submission of the bids.
- 7. <u>Tender Fee (Non-refundable):-</u> Bidders are required to submit Tender Fee for amount of <u>Rs.</u> 2,000/- (Rupees Two Thousand only) along with their bids. The Tender Fee may be submitted in

- 8. E.M.D.:- Bidders are required to submit Earnest Money Deposit (E.M.D.) for amount of Rs. 33,500 /-(Rupees Thirty Three Thousand Five Hundred only) along with their bids. The E.M.D. may be submitted in the form of an Account Payee Demand Draft from any of the public sector banks. Demand draft/ Bank Guarantee/ F.D.R./ N.S.C. Passbook should be drawn in favor of "The Registrar, Vinoba Bhave University, Hazaribag".
 - E.M.D. of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The bid security of the successful bidder would be returned, without any interest whatsoever, after the successful completion of work as per work order.
- 9. The EMD will be forfeited if the bidder withdraws or amends impairs or derogates from the tender in any respect within the validity period of their tender.
- 10. There should not be overwriting or correction or cutting in the bid and each page of the technical bid as well as the financial bid should be signed by and authorized representative of the firm/agency.
- 11. The University reserves the right to accept or reject the tender/ work order or relax any condition without assigning any reason.
- 12. Price Bid: The bidders have to quote their rates in the blank space provided on the B.O.Q. (B.O.Q.- attached at Annexure- A)
- 13. The interested contractors may visit the work site for their cost assessment and for quoting their rates.
- 14. Payment will be made after statutory deduction as per Govt. rules.

PART II- Special Conditions of Tender:-

- In case of any discrepancy between rates mentioned in figures and words, the offer in words shall prevail. If there is any discrepancy, between the unit price and the total, the unit price shall prevail and the total price shall be corrected.
- 2. Vinoba Bhave University, Hazaribagh reserves the right to forfeit the E.M.D. amount deposited if the bidder fails to supply and install all the items in stipulated period as mentioned above.
- 3. No representation for change of rate once accepted shall be considered.
- 4. If the items supplied & installed by the accepted bidder are not as per the specified specification of the tender, Vinoba Bhave University, Hazaribag reserves the right to reject them.
- 5. The Tendering Authority will award the work to the successful bidder whose bid has been determined as the lowest evaluated bid provided further that the bidder is technically eligible.
- 6. Bidders are strictly advised to submit the details of full specifications along with warranty period with technical bid.

Technical Specification of RCC precast boundary wall:-

1. Components:

Posts: Typically 6" x 6" in size, with a standard height of 8'0", including some portion buried below ground (Approx 2'0"). They can be reinforced with 8 bars of 4mm diameter and 4mm diameter stirrups @2'0"c/c.

Panels: These are the infill sections between the posts, usually 2" thick. Panel dimensions is 7'0" long x 1'0" high. They are reinforced with 4 longitudinal bars (4mm diameter) and 4mm MS stirrups @ 2'4" c/c.

2. Materials:

Concrete: M25 concrete is commonly used for both posts and panels, ensuring durability and strength.

Reinforcement: High tensile carbonized steel wire are used for reinforcement, providing the necessary tensile strength to withstand various loads and stresses.

3. Construction:

Post Installation: Posts are typically set into the ground within pre-dug holes and secured with concrete backfill.

Panel Installation: Panels are designed to slide into grooves or slots on the posts.

Joints: Joints between panels and posts are usually sealed with mortar or grout for a weather tight and secure connection.
